INDRANI GANGULY, WARDEN JADAVPUR BIJAYGARH RESIDENTIAL HOSTEL

I am Indrani Ganguly. I was appointed as the Warden of Jadavpur Bijaygarh Residential Hostel, run by Maya Foundation, on September 1, 2023. From that day on, a new journey in my life began. My main goal was to help all students in creating their own identity through discipline and hard work. I not only taught them, I also learned a lot from them, and what I received most from them was love and respect. I am very grateful to the head of this Organization and our esteemed Dr. Minakshi Gangopadhyay who gave me an opportunity of working in such a beautiful field, moreover, for giving me the gift of a loving family – Maya foundation.

MADHUBI MAZUMDER, CARETAKER – KALIGHAT, UNIT-1

I am Madhabi Mazumdar ; due to family turmoil, I had to return to my parents' house at the end of 2019. My son is engaged in a private company, accommodating himself in a city mess. He visits me once a week. I spend my days wondering what to do without work or activity.. The situation became worse with the spread of Corona epidemic, followed by "lockdown".

In the meantime, I kept searching for some kind of a job, talking to friends and well wishers if they would recommend.

Suddenly, one day, a friend called to say that there is a job opportunity in an NGO, if I was interested she would help. Even though I had no experience of working in an NGO, I agreed to go for an interview.



Three days later I was asked to meet the Manager of Maya Foundation for a preliminary interview.

After explaining my background and answering a few practical questions, the Manager offered me the job of a Caregiver in Shelter for Homeless at Kalighat-Unit-1, under the project DAY-NULM, supported by KMC and WB-SUDA.

Along with other staff I had to take care of 225 homeless, according to the established guidelines and practices. During the eight hour duty schedule, I got deeply involved with the lives of the helpless, rejected and dejected people under my care and by and by I learnt to overcome my own mental strains and short-comings.

For the past five years I have been serving in SUH-Kalighat-1 with a sense of satisfaction and dignity.

For this second chance in life and certain empowerment, I need to express my deep appreciation and gratitude to the Chairperson Smt Dr Minakshi Gangopadhyay and the Secretary Sri Dr Pallav Gangopadhyay for their uninterrupted support and blessings which made it possible to be what I am today.

RAJKUMAR GURIA, PROGRAMME MANAGER – TI PROJECT

As the Program Manager of the Bridge Population (Transport workers with migrant laborers) plus OVP TI Project at Maya Foundation, I've had the privilege of working with this esteemed organization since 2022. Our team has been tirelessly working on the targeted intervention project in Hooghly district, supported by the West Bengal State AIDS Prevention and Control Society (WBSAP&CS) and National AIDS Control Organisation (NACO), Govt. of India.

Our project focuses on conducting regular health checkups, community-based screening, and testing to identify HIV-reactive clients among truckers and transport workers. We also organize

annual awareness and health camps on World Aids Day and other special occasions.

Our key objectives include increasing population coverage and services, detecting HIV-reactive cases, reducing myths and misconceptions about HIV/AIDS, and providing counseling services, TB screening and STI treatment. We also aim to empower and mobilize the truckers community to ensure project sustainability. Through our efforts, we have been able to promote safe sex practices, reduce HIV stigma and discrimination, and create social bonding through various festivals and events.

We have also linked HIV-reactive clients to ART centers for proper treatment and continuously follow up with PLHIV clients. We also work with others organizations and municipality to make the program better. Overall, our project has made significant progress in supporting the health and well-being of truckers and transport workers at Hooghly district.

I am grateful for the opportunity to work with Maya Foundation, under the guidance of our respected Project Director, Dr. Minakshi Gangopadhyay and Secretary Dr. Pallab Gangopadhyay. Their unwavering support and leadership enabled us to effectively reach out to the challenging population of long distance truckers and transport worker. Their guidance has been instrumental in our success, and we continue to work diligently to make a positive impact in the lives of these truckers and transport worker.

FIELD ACTIVITIES DURING THE YEAR 2024 - 2025

SOCIAL HEALTH IMPROVEMENT

EYE CHECK-UP CAMP :

Maya Foundation in collaboration with Lions Club Kolkata organized a free eye checkup camp for children of Park Institution School and children of Bijayagarh Residential Hostel. We believe that children are the future of the nation, therefore, education and health & hygiene of children are core activities of Maya Foundation. In most cases children and their family members tend to ignore regular check up of eyes and they keep on adjusting their vision through strain and force, as a result children at an early age are bound to put on spectacles and it becomes a lifelong partner. On the other hand, if parents are vigilant and observe their children closely, take initiative of regular eye checkups then this effort shall definitely help in ruling out blindness-causing conditions like glaucoma, powered vision, squints etc. As of date Maya Foundation has conducted eye checkup camps for over 300 children. Free glasses have been provided to children who were diagnosed having powered vision.



THALASSEMIA & AIDS:

Maya Foundation in collaboration with Thalassemia Prevention Federation celebrated World Thalassemia Day like every year by participating in a big awareness rally and blood donation camp organized by Serum. The basic aim was to create awareness among people about Thalassemia that this is not a contagious disease, but a genetic disease. This is a very important health and life issue which is not clear to many people, so they are scared of Thalassemia patients. Through this mass rally, the general public was made aware of the facts that Thalassemia patients are in need of our love, patience and understanding and that they are as normal human beings as any of us.



World AIDS Day too, was celebrated through awareness programs in each of Shelter for Urban Homeless under administration of Maya foundation, making the inmates and staff aware about the disease (AIDS), its consequences and prevention.

TARGETED INTERVENTION :

The Bridge Population of HIV/AIDS/STD Targeted Intervention Program among Long Distance Truckers (previously the sole focus, now a key part of the bridge population) project was launched on 1 December, 2021 by Maya Foundation. Total target population is 10,000 transport workers & Other Vulnerable Population (OVP). Our field area is mainly Dankuni, Chanditola-1, Chanditola-2, Singur & Sreerampur of Hooghly district, West Bengal. Truckers are coming from different states of India, like Bihar, Orissa, Punjab, Rajasthan, Andhra Pradesh, Tamilnadu, Hariyana, Uttar Pradesh, Maharashtra, Chatrisgarh, Jammu & Kashmir, Nagaland etc. Previously our HRGs were long distance truckers who travel 800km and above but According to the NACP-V revised guideline the new concept

is Bridge and Other Vulnerable Population (OVP). Transport workers are included in our target population like auto driver, toto driver, rickshaw puller, van chalk, taxi driver and Other Vulnerable Populations (FSW, MSW, TG, MSM/Hijra, PWID). The program targets key congregation points and hotspots to maximize its reach. This includes 10 identified hotspot sites. The program actively seeks out and engages with these diverse and often hard-to-reach populations. These long distance truckers are more vulnerable to HIV/AIDS because they have to spend day after day on the highway. They have less chance to have sex



with their regular partner or wife. As a result, they do sex practice with TG & FSW or even practice MSM activity between driver & khalashi. According to NACP-V guideline truckers act as agents by which HIV is moving from small high risk groups to the general population. People who are away from homes and families for long periods of time often indulge in risky sexual behavior which makes them more vulnerable to HIV. We divide our work into several sessions to run the project smoothly and we raise awareness through street plays and counseling. Our project & mission was to reduce new HIV infections among HRGs and ensure that 95% and more HRGs know their HIV

status. To promote better sexual health among transport workers, migrant labours (Destination) and Other Vulnerable Populations (OVP) at various truck terminals or halt points in the Hooghly district area, create STI/ HIV/AIDS prevention and awareness among people in our community. Our target was 10000. We organized Health Camps at Dankuni, Chanditola-1, Chanditola-2, Singur & Sreerampur of Hooghly district, West Bengal. Those whose reports come positive, we bring them to the nearby health center and they are treated.

GENERAL HEALTH CHECKUP :

General health check up is very important for every person. We do a general health check up for each of our SUH's inmates every month in cooperation with the municipality there. Also during Durga Puja we conduct health camps at three places Pallyshree, Gouribari and Telangabagan.



MAINTAIN HYGIENE:

Diseases can be avoided by maintaining regular health and hygiene practices. In this direction, the inmates living in shelter homes are taught to live a clean and tidy life through trimming of nails, regular hair cut, shaving, daily showers, wearing of clean clothes, cleaning of comb, weekly washing of bed sheet, pillow case, etc; besides cleaning and sweeping of the shelter floors, kitchen, toilets and the entire campus under supervision of the caregivers.

COOKED MID-DAY MEAL :

Maya Foundation is proud to be associated with this project of serving cooked nutritious meal to 37 government schools in Kolkata. The West Bengal government introduced mid-day meal in schools to improve the nutritional status in young children and enhance interest in regular schooling and help in the reduction of school dropouts. This live activity for the past few years, has earned the organization appreciation and favourable comments from school authorities, Govt Departments and general public as well.



MAA CANTEEN :

Maa Canteen Scheme was launched by the West Bengal Government in 2021 for the underprivileged people in providing a square meal at rupees five (Rs 5/-) only. The main objective of launching this project was to provide nutritious food at low cost to the hungry and underprivileged people so that no one in the state dies of malnutrition or hunger. Maya Foundation is running 11 Maa Canteens in different wards. The Maa Canteen meals are being cooked centrally in KMC School at Deshbandhu Park as per guidelines of Samagra Shiksha Mission. This Scheme is another feather in the cap of Maya Foundation.

CHILDREN SOCIAL INTEGRATION AND EDUCATION

NABADISHA :

Nabadisha is an initiative of the Kolkata Police in collaboration with Maya Foundation to help and motivate the underprivileged children of the city, especially the slum dwellers, in increasing genuine interest in basic education and development of various skills towards job



opportunities. The project started in 1997 with 11 centers and has come a long way since then. Now there are 35 centers in



different police stations with approx 1600 children. Under Nabadisha project, Maya Foundation devotes energy, time and teaching staff through regular evening classes with emphasis on mainstreaming of poor and ignorant children. The classes are held from 5 pm to 6.30 pm five days a week in the campus Ultadanga Police Station. Besides academic studies, the curricula includes participation in quizzes, drawing competitions, sports and lessons on etiquette and good manners, sharing and leadership initiatives.

BIJAYGARH RESIDENTIAL HOSTEL FOR GIRLS :

One of the important pillars of the vision-mission of Maya Foundation is "Children Social Integration and Education" and in fulfillment of this philosophy Maya Foundation is running a girls' residential hostel in Jadavpur Bijoygarh Shikha Niketan in collaboration with Samagra Shiksha Mission. The capacity in the hostel is for 100 students. Most of the girls are from BPL families that are unable to support education of girl children and opt for early marriage so that one burden becomes less for the poverty stricken families.



The children in the hostel live a life of discipline and good habits and manners. They are taught the importance and value of education and self-skill in areas of their interest so that they are able to stand on their own feet when the need arises. They learn to excel in studies, sports, singing and dancing, playing musical instruments, yoga, basic cooking for which special coaching is arranged. The students are encouraged to take part in opportunities and competitions of debates, quiz, drawings, singing and dancing, sports, excursions and of course in puja festivals. The entire facility provided to the students is free of cost. This twenty-four hour devoted selfless service by the staff of Maya Foundation is not only commendable but also highly acknowledged by the Education Department, sponsors and well-wishers.

SUH-KALIGHAT UNIT-I:

In Shelter for Urban Homeless, Kalighat Unit-1 there are fifty children all from the neighbouring slum areas, where these children suffer from acute poverty. Now with a roof over their head, in safe and secured environment, timely food and decent clothing, the children are learning fast the importance and value of education, discipline in day to day life and some skill development for self assertions and job opportunities later in life.

This endeavour is in line with concept and principle of Children Social Integration and Education. The service rendered to these children is entirely free of cost.



WOMEN SOCIAL EMPOWERMENT

Social empowerment of women is an integral part of sustainable progress and development for any nation. True achievement of any society or race is measured by the quality and depth of empowerment of their female population.

Maya Foundation is active in this field through implementation of a good many activities with emphasis

and focus on empowerment of women, especially those who are poor, under privileged and down trodden.

MID-DAY-MEAL & MAA KITCHEN :

The launch of the twin projects, namely, Mid-Day Meal and Maa Kitchen has offered opportunities to a number of house-wives and women in need who had earlier never thought that through cooking and serving of meals they could earn for their families. Most of the women engaged in these projects are poor, illiterate and belong to different religions. They are well trained in health & hygiene, cooking of nutritious meals and serving in time as per the day's schedule. Many of them are certificate holders in "Cook cum Helper Training" conducted by Utkorsho Bangla. Through this regular earning process, the women and their families are experiencing financial empowerment.



SUH-ASANSOL :

In SUH-Ashray, Asansol, the female inmates have been trained in making incense sticks which are sold through a small counter set up just in front of the main gate of the SUH-Ashray. The inmates are happy to earn their own pocket-money with hard work and dignity. This is another example of commitment of Maya Foundation towards the principle of women empowerment.



SOCIAL BONDING ENHANCEMENT

SUHF—TELENGABAGAN, KOLKATA :

Shelter for Urban Homeless Women is another project being implemented by Maya Foundation since April 2012 with the aim and objective of enhancing the spirit of social bonding with and among fellow human beings from all walks of life. The inmates consist of women who earn their living through rag picking, construction labourers, roadside vegetable vendors and such other menial engagements. After the day's hard work, they take shelter for the night in this Shelter Home for Women, located on the second floor of the Head Office building of Maya Foundation at Telengabagan, Kolkata. These poor and unfortunate women find the Shelter Home as a "home away from home", clean and tidy, homely

atmosphere with a loving and caring caregiver, ever ready to listen, understand and cooperate. The inmates are free to spend their time in watching TV, playing indoor games or just sharing with each other slices of life, enhancing their relationship and bonding of love and empathy.

The authority of this project, namely Department of Women and Child Development and Social Welfare, Govt of West Bengal, is happy and appreciative of this success story in which Maya Foundation has played a prominent role.

SUHM – RAJABAZAR, KOLKATA :

Similar to the above project, Maya Foundation is running a Shelter for Homeless Men in the Urban areas of Kolkata. The shelter is being operated from the second floor of a prominent building at Rajabazar, Kolkata since August 3, 2013.

This Shelter for Homeless Men has gained popularity due to its location, (being in the centre of one of the busiest areas of the City), efficient service rendered by the staff and provisions of other social and charitable inputs initiated by Maya Foundation for sole benefits of the inmates.



The inmates consist of men, mostly from outskirts of Kolkata, even as far as Murshidabad, Canning, Hasnabad, seeking jobs in the city but have no place to rest or unable to rent a shelter. Therefore, this Shelter for homeless men at Rajabazar is a "God given" care and love centre. These inmates are the ambassadors of goodwill of Maya foundation, so much so, a number of organizations visit and enquire about the success story of running a shelter for shelterless men at

Rajabazar, Kolkata The Govt, through it's Department of Women and Child Development and Social Welfare has also acknowledged the efficient implementation of the Scheme.

SUH – TARAKESWAR, HOOGHLY :

Shelter for Urban Homeless (SUH) under the administrative control of Tarakeswar Municipality is being run by Maya Foundation since May 2023. It follows the same rules, discipline and practices that are being implemented in five other SUHs under Maya foundation; accordingly the SUH at Tarakeswar is clean and tidy like a Mandir - homely, caring and loveable destination for the shelterless people who

come to the shelter from all walks of life. Besides, timely nutritious food, medicines, health check ups, livelihood opportunities, the inmates are also assisted and guided towards basic documentation process like Aadhaar Card, Voter Card enabling them to be beneficiaries of Social Welfare benefits launched by the Govt.

SUH-KALIGHAT, UNIT - I, KOLKATA :

The Shelter for Urban Homeless in Kalighat Unit - I, Kolkata is being run by Maya Foundation, supported by WBSUDA & KMC for the past few years. This Shelter is unique in many ways. It is spacious with the capacity of 100 inmates. The inmates consist of not only elders but also children. Therefore, besides normal and established activities required for smooth running of a SUH, additional responsibilities and disciplines have to be carried out, for instance, school admission and continuation of education, coaching assistance, games and sports, music and dance, debate and elocution enabling the children to grow up as other main stream children.



The elders on the other hand are assisted and guided to keep themselves and the premises clean and tidy, utilization of time for livelihood opportunities, meditation and prayers. Due to the efforts and concerns of the well trained Staff, many of them are now beneficiaries of the Social Welfare Schemes of the Govt as well as recipients of Social Entitlements. Kolkata Municipal Corporation as the implementing agency of the SUH scheme, regularly inspects the O & M of Kalighat SUH and are well satisfied with the performance of Maya Foundation.



SUH - ASHRAY KULTI & ASHRAY ASANSOL :

MAYA FOUNDATION is operating and maintaining two Shelters for Urban Homeless (SUH) under the administrative jurisdiction of Asansol Municipal Corporation, one at Kulti and the other at proper Asansol town.

Inmates are brought to these Shelters through regular day/night surveys. After mandatory registration, they are provided with a clean and tidy living environment, each one having his/her own steel-frame bed, beddings and of course four square meals a day. During the course of their stay in the Shelter, the inmates are taught and encouraged to undertake activities towards

self-earning through making of paper packets (thongas), daily laborers in farm fields, gardening, security etc. Medical Practitioner visits every month for physical health checkup and counseling on general

health and hygiene including yoga exercises. The inmates are involved in keeping the shelter hygienic and green through weekly deep cleaning and maintenance of a Kitchen Garden for vegetables. In the evening the inmates enjoy playing indoor games (ludo, carrom board, Chinese-checkers, cards), reading of News paper, watching TV or singing of bhajans and kirtan. Besides, Maya Foundation takes the initiative of ensuring that the inmates are equipped with entitlements of Aadhaar card, Voter card, Bank Account and other social benefits like Swastha Sathi, Widow/Old age pension, Lakhi Bhandar, Ration card etc. The Authority of Asansol Municipal Corporation is happy and appreciative of the efficient services rendered by Maya Foundation.



SUH – SAINTHIA, BIRBHUM :

In Sept 2023 the Shelter for Urban Homeless in Sainthia was handed over to Maya Foundation by Saithia Municipality for operation and maintenance. The SUH started with just ten inmates but by and by through our continuous day/night surveys in railway station area, common market place, bus stands and temples, people without shelter started coming to the SUH and making it their home. Gradually the number of inmates increased to thirty, enjoying the hospitality of the staff of Maya foundation.

However, in Feb 2025, due to some unresolved matters and constraints, Maya Foundation, handed over the O & M of the SUH to the Authority of Saninthia Municipality.

SUH – DISHARI, SANTIPUR :

The Shelter for Urban Homeless, popularly known as DISHARI, under administrative jurisdiction of Santipur Municipality was formally handed over to Maya foundation on 1st July 2021 for day to day operation and maintenance. Since then and till the time of writing, Dishari has achieved an envious position of excellence in all aspects of O & M. Quarterly Audit reports under direction of SUDA, certify this satisfactory position of DISHARI.



For the past four years, Maya Foundation with support of Santipur Municipality, has been celebrating "birthday" of DISHARI in the first week of July. It is an occasion of joy, sharing and expression of gratitude. It is a gathering of prominent NGOs, sponsors, benefactors, well-wishers, councilors, officers and staff of Santipur Municipality. The honoured guests mingle with the inmates wishing them "happy birthday" while the inmates express their gratitude and thanks for their support and charity.

Like the inmates in other SUHs under O & M of Maya Foundation, the inmates of Dishari too enjoy the facilities and benefits of Entitlements and Social Welfare Schemes of the Govt.

SUCCESS STORIES

● **SUH-Ashray Kulti:**

One of the major activities of a SUH is regular surveys and rescue of shelterless people. During one such survey, a young girl (18+) was rescued from the vicinity of Asonsol Railway Station, with the support of Railway Protection Force. She did not react to any of our queries but listened and followed all the instructions. Initially we thought that she was dumb but after a few days of counselling by experts from One Stop Centre, this girl started to open up and tell the sad story of her life. It seems that her parents wanted her to earn through prostitution but she refused and ultimately ran away from the clutches of her parents. She found the Shelter Home safe and secure, moreover, she felt grateful to the Staff for their love and care. After a few weeks, she became one of the most active inmates through her initiatives in the kitchen, keeping the campus clean, a jolly happy person spreading joy in the shelter.

● **TARGETED INTERVENTION (TI):**

TI project is a bright feather in the cap of Maya Foundation. It is a life saving, family saving activity – basically it is a continuous attempt and effort to prevent spread of HIV disease through one to one contact programme, testing facility, counselling and well planned motivational workshops.

The vulnerable and targeted group is the long distance truck drivers who are usually far from their families for days, driving through different geographical terrains, communities and living conditions. As a result, they are prone to fall into the trap of unprotected sexual activities, leading to HIV infection and making it contagious through multiple sexual partners.



● **Namita Das :**

Namita Sarkar is one of the inmates of the urban shelter for female unit. She has been with us since the beginning. She works in people's homes, saves money little by little and buys a room. We are very happy about this.

● **Rinki Jaluya :**

Rinki Jalua, was admitted to our Jadavpur Residential School on September 10, 2016. She came from a very underprivileged family. The girl was very attentive and interested from the very beginning. We were realized that if he gets a good environment and a little guidance, his future could be better. Apart from studies, she is equally good at singing, dancing, drawing, etc. She has participated in various competitions and won many awards. He was successfully passed his secondary school from here. We are wish him a bright future.

● **Nabadisha :**

We was organized a program "Draw as you like" with children and their mothers on 19.01.25 this year. Our aim was for the children and their mothers to escape from their monotonous lives and return to their childhood, a few moments. We were



succeeded in that goal. Each child's mother also participated, and they went beyond our expectations and draw very beautiful beautiful picture . As feedback, they told us that they were very happy to participate here. Not only the mothers, but also the three female police officers from the women's department of our Ultodanga Police Station were motivated to draw with the mothers. We would like to express our sincere gratitude to Ultadanga Police Station OC Mr. Swapur Kanti Pahari and Sergeant Mr. Prasen Raj Gupta and their team.

● **INTERNSHIP OPPORTUNITY :**

It is a matter of satisfaction and achievement in a way that May Foundation through its policy of social development at grass-root level, has earned a standing goodwill which is much sought

In the current year six interns have completed their internship with flying colours. Reputed institutes like St Xavier's College (Autonomous), Kolkata, Netaji Subhas Open University, Kolkata, SRM Institute of Science And Technology, Kattankulathur Main Campus are frequently sponsoring students for internship in Maya Foundation.

● **COLLABORATION :**

It is in the spirit of supplementary and complimentary disposition that an NGO progresses and earns its goodwill.
